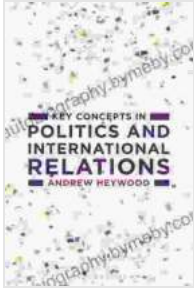

POWER, AUTHORITY & LEGITIMACY

CRITICAL THEORY

Critical theory is a social theory that describes and analyzes society and social norms, typically with the aim of enhancing the freedom of the individual while preserving social justice.

Uses a realist ontology (there is such a thing as an external reality)

The main aim is social transformation and emancipation through critique.

CONSTRUCTIVISM

Constructivism is a theory that states humans construct knowledge through their intelligence, experiences and interactions with the world.

Supports the individual construction of social reality.

The main aim is exploring the concept of reality and knowledge.

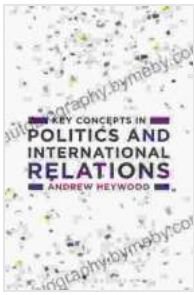

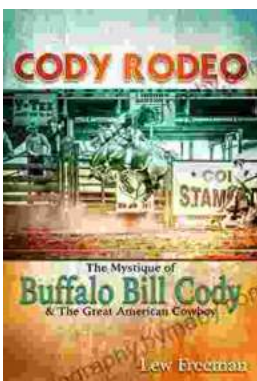
