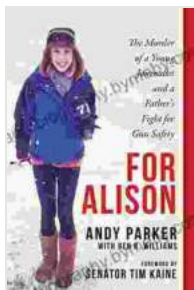


# The Murder of a Young Journalist and Father: A Fight for Gun Safety

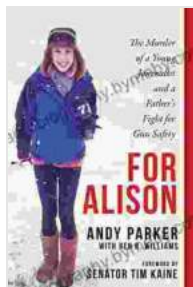
